


## TEMPLATE LAYOUT STYLES FOR WORDPRESS EASY CONTENT MANAGEMENT

You have a choice of a variety of different layouts. I suggest you have our designers select two for you to choose from but if you have a particular preference please let me know <u>before</u> we create the designs.


Layout 1 (navigation is along the top)




Layout 2 (navigation is on left-hand side)




Layout 3 (header photo is across from navigation) (content area is large)




Layout 4 (header photo is across from navigation) (content area is narrower)

#### 2. Revisions

Graphically Speaking Services shall deliver 1-2 design renditions with **up to 1 revision cycles** during development. Revisions that exceed 10% of the assigned fees will be billed over above the project fees.

#### 3. Client Deliverables

All client-supplied web site content (text, images, etc.) will be provided to Graphically Speaking Services in digital format unless otherwise agreed upon.

#### 4. Intellectual Property Rights

Upon final acceptance of the completed project and full payment of project fees, any and all intellectual property used and created in connection with the web site including, without limitation, all design, logo, trademarks, trade names, copyright material and content (excluding any such material identifying Graphically Speaking Services Inc.) shall be and will remain the property of Bruce W. Lemer.
